WHEREAS, The Board of Commissioners of the Bainbridge Island Metropolitan Park & Recreation District has a responsibility to ensure an efficient and cost effective district operation; and

WHEREAS, the Board of Commissioners has the power to dispose of real and personal property as provided in RCW 35.61.132; and

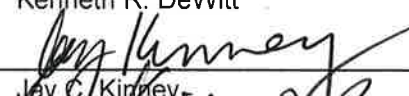

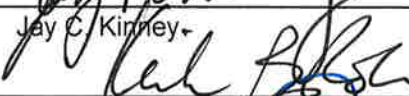

EXHIBIT A

PARK SERVICES VEHICLE AND EQUIPMENT 2017 SURPLUS

Item 1) Truck #4, 1995 Ford F250. It's scheduled FOR replacement this year. Market value \$100 - \$500

Item 2) Truck #6, 1994 Chevrolet c1500. It's scheduled for replacement this year. Market value \$100 - \$500.

Item 3) Mower #M40, 1999 Jacobsen HR9016. Mower is well used and is scheduled to be replaced this year. Trade in value of \$3000. Market value \$3000 - \$10,000.

Item 4) Mower #M45, John Deere 52" walk behind. Mower is getting replaced this year with a more user friendly machine. Trade in Value of \$900. Market value \$900 - \$1000

Item 5) Outboard #BM3, 2005 Yamaha 25hp. Engine or lower unit seized up, Outboard was replaced last year. Market value \$50 - \$200

All items will be sold on Public Surplus auction site. Items #3 & #4 will get traded in if the auction doesn't meet the reserve price of the trade in value.
